

The Lithium ion cell according to Section II of PACKING INSTRUCTION 965-967 of the 2021 IATA Dangerous Goods regulations 62nd Edition may be transported. and applicable U.S. DOT regulations for the safe transport of Lithium-ion Battery.

Lithium ion cell was protected so as to prevent short circuits. This includes protection against contact with conductive materials within the same packaging that could lead to short circuit;

Cell and batteries offered for transport must be packed in inner packaging's that completely enclose the cell or battery; to provide protection from damage or compression to the batteries, the inner packaging's must be placed in a strong rigid outer packaging;
